TO CONSIDER AND DECIDE WHETHER NMC GUIDELINES FOLLOWED FOR SUBMISSION OF THESIS FOR MD/MS/MDS COURSES AND THE SAME MAYBE FOLLOWED FOR DM/M.CH COURSES.

It is submitted that the Executive Council, in its 45th meeting held on 27.06.2022 vide agenda item No. 45.26 approved and revised the calendar for submission of Thesis Protocols & thesis for MD/MS/MDS/DM/Mch courses to be implemented from the Academic year 2021 asunder:-

“Submission of 01 Hard copy and 02 CDs of thesis in the Office of the Controller of Examinations within 09 months before final examination. E-copy to be sent to (02) external evaluators only within one month of submission of thesis by Controller of Examinations, UHS, Rohtak.”

It is further submitted that as per NMC PG Medical Education Regulations, 2000 amended upto May, 2018 the clause No (11) Sub Para 4(a): Doctor of Medicine (M.D)/ Master of Surgery (M.S), the rules regarding submission of thesis are as under:-

“Thesis shall be submitted at least six months before the theoretical and clinical /practical examination. The thesis shall be examined by a minimum of three examiners; one internal and two external examiners, who shall not be the examiners for Theory and Clinical; and on the acceptance of the thesis by two examiners, the candidate shall appear for the final examination.”

The above said case was put up before the Vice Chancellor who has desired that NMC guidelines for MD/MS may be followed for DM/MCh Courses and also ordered that proposal may be put-up in forthcoming Academic Council Meeting. The proposed guidelines alongwith minutes of 45th Executive Council and the NMC guidelines/DCI guidelines/University Ordinance are as under:-

In addition to above, the under-mentioned NMC guidelines may also be included in the draft agenda item for getting approval of the Academic Council:-

- Internal Examiner for thesis evaluation shall not be the supervisor/Guide.
- In case there is no eligible internal examiner in respective specialty, the thesis shall be examined by third external examiner.

Hence, the matter was placed before the Academic Council for its consideration and approval and further recommendation to the Executive Council for consideration please.

The Academic Council considered and resolved to approve the proposal with the following amendments:-

1. **The thesis shall be examined by a minimum of three examiners; one internal and two external examiners, who shall not be the examiners for Theory and Clinical examination. A candidate shall be allowed to appear for the Theory and Practical/Clinical examination only after the acceptance of the thesis by the examiners.**

TO CONSIDER AND CONFIRM THE ACTION TAKEN BY VICE-CHANCELLOR FOR GRANTING PERMISSION TO CHANGE IN THE NOMENCLATURE OF SPECIALITY OF PULMONARY MEDICINE TO RESPIRATORY MEDICINE IN WORLD COLLEGE OF MEDICAL SCIENCES & RESEARCH, JHAJJAR AFTER APPROVAL BY THE NMC AND THE STATE GOVT.

It is submitted that consent of affiliation was granted to World College of Medical Sciences & Research, Jhajjar to start PG course in Pulmonary Medicine vide letter dated 15.02.2023 at **Annexure-21.08/A**. On the behalf of assessment team it was found that Pulmonary Medicine is different from Respiratory Medicine. The NMC issued permission for starting PG course in Respiratory Medicine vide its letter dated 21.06.2023. The college has NOC of the State Govt. and consent of affiliation to start PG course in Pulmonary Medicine but NMC issued permission for starting PG course in Respiratory Medicine. The college was requested to apply for consent of affiliation to start PG course in Respiratory Medicine. The State Govt. issued NOC to the said college to start PG course in Respiratory Medicine for 03 seats on dated 02.08.2023 annexed at **Annexure-21.08/B**. The last date for granting provisional affiliation/extension in provisional affiliation for the session 2023-24 was 31/07/2023.

Since the inspection of the College for various specialties had been done before 31.07.2023 and change in nomenclature of one of the specialty from Pulmonary Medicine to Respiratory Medicine was to be done at the level of the Government which was communicated to the University
